

**SETON HIGH SCHOOL**  
2018-2019 School Year  
**FACTS Tuition Information**

Tuition for the 2018-2019 school year is \$10,600 plus fees of \$1,000 for a total of **\$11,600**.

Seton High School uses FACTS Management Co., a third party tuition collection company for all tuition payments. **All families must have a FACTS account, even if you are paying your tuition in full.** To set up a new FACTS account, go to [www.setoncincinnati.org](http://www.setoncincinnati.org), Admissions, Tuition and Financial Aid, and click on the link "FACTS Online Payment Setup". For families who set up a FACTS account for the current school year, you will not have to set up a new FACTS account. Please review your information and make any necessary changes. If no changes are necessary FACTS will automatically reenroll you using your current information and payment method. New families are required to set up a FACTS account. All account creations and/or necessary changes should be completed by March 16, 2018.

**Tuition Payment Options**

FACTS offers four payment options: Pay in Full, Monthly, Quarterly and Semester.

**Pay in Full Option**

- A one-time payment due to **FACTS** by August 1, 2018.
- Seton offers a \$150 early payment discount to families that **pay the full** tuition amount. In order to be eligible to take this discount, you must be paying the full tuition amount and **receiving no Seton Financial Aid or Scholarship**.
- **You must set up a FACTS account to pay your tuition in full. There is no FACTS enrollment fee for a one-time payment plan.**
- Payments can be paid to FACTS by electronic transfer (ACH), check or credit card, a 2.85% convenience fee will be assessed for credit card payments.
- If you choose the Pay in Full option, no payment is required in June and July.

**Monthly Payment Option**

- Enrollment fee to FACTS is \$43.
- 12 monthly payments to FACTS due on the 5<sup>th</sup>, 10<sup>th</sup>, 20<sup>th</sup> or last day of the month from June 2018 through May 2019.
- Electronic Transfer – Automatic bank payments (ACH) through your checking or savings account. *ACH payments are preferred for administrative purposes.*
- Check – Monthly invoices will be sent from FACTS.
- Credit Card – FACTS will charge your credit card monthly. In addition to the FACTS enrollment fee, a 2.85% convenience fee will be assessed for each credit card payment.

## Quarterly Payment Option

- Enrollment fee to FACTS is \$43.
- 4 payments to FACTS due quarterly on the 5<sup>th</sup>, 10<sup>th</sup>, 20<sup>th</sup> or last day of the month in June 2018, September 2018, December 2018 and March 2019.
- Electronic Transfer – Automatic bank payments (ACH) through your checking or savings account.
- Check – Quarterly invoices will be sent from FACTS.
- Credit Card – FACTS will charge your credit card quarterly. In addition to the FACTS enrollment fee, a 2.85% convenience fee will be assessed for each credit card payment.

## Semester Payment Option

- Enrollment fee to FACTS is \$10.
- 2 payments to FACTS due on the 5<sup>th</sup>, 10<sup>th</sup>, 20<sup>th</sup> or last day of the month in June 2018 and December 2018.
- Electronic Transfer – Automatic bank payments (ACH) through your checking or savings account.
- Check – Semester invoices will be sent from FACTS.
- Credit Card – FACTS will charge your credit card each semester. In addition to the FACTS enrollment fee, a 2.85% convenience fee will be assessed for each credit card payment.

## **ADDITIONAL INFORMATION**

FACTS tuition accounts must be set up by **March 16, 2018**.

Please note that tuition accounts **must** be current before a student will receive a class schedule and be admitted to classes. (This means we must receive a June, July and August payment or payment in full by August 1 to be considered current.)

Tuition amounts for each payment plan will be adjusted for the registration fee, scholarships and/or financial aid. **Any outside grants or scholarships will be posted to your FACTS account when payment is received at Seton.**

If parents split tuition payments, each parent must set up their own FACTS account.

If you have three or more children enrolled in an Archdiocesan high school, an additional \$1,250 discount will apply to each Seton student. Please **notify** the business office if you are eligible for this discount.

If you participate in the ACEO or Western Scouters programs, **you must still make your regularly scheduled payments to FACTS**. Seton will adjust your FACTS account as soon as we receive payment from these organizations.
