Commitment Form

I hereby make my commitment as follows:

- 1) I am part of a group of 30 women that will support a young woman through Seton High School starting in fall of 2020 and ending with graduation in 2024.
- 2) At a minimum, I will make 48 equal donations of \$33 starting April 1, 2020 and ending March 1, 2024. I understand that I must keep up this schedule in order for the fund to have sufficient assets to cover costs on an ongoing basis.
- 3) I may pay the entire \$1,584 or balance thereof at any time during this time period.

I understand that the management of the fund will be as follows:

- 1) The fund will be housed and managed by Seton High School.
- 2) Direction of disbursement will be by Seton High School.
- 3) The fund will cover most of the following each of the four years:
 - a. Tuition
 - b. Books
 - c. Fees
 - d. Tablet PC
- 4) Excess funds may be used at the discretion of Seton High School for:
 - a. Field Trips
 - b. Prom Expenses
 - c. Lunch Program
 - d. Other fees
 - e. Tuition assistance for additional students
- 5) The fund will bear no expense from Seton High School and will also be non-interest bearing.
- 6) All accounting, tax letters, etc. will be completed by Seton High School.
